ABOUT WCD BOARDNEXT

BoardNext is an initiative of Women Corporate Directors (WCD) designed for highly qualified, board-ready women in North America to accelerate the path to a board seat. A BoardNext membership provides an important set of tools to support members in their board search including access to leading board education content and events, strategies and skills-building advice to help with the journey, a strong network of peers and active board members, and access to a wide range of board opportunities for members to pursue.

There are also two BoardNext Chapters available for those local to the NewYork or Los Angeles regions, which offer education and networking focused in-person events.

All WCD BoardNext members (virtual, LA or NY) are able to participate in our programming, and virtual members can attend BoardNext New York or Los Angeles events if they are ever in the region.

WCD BoardNext Women are:

Current or retired CEOs or C-suite executives reporting to the CEO of a public company;

Current or retired C-suite executives of a significant corporate division (representing over 10% of corporate revenue) reporting to the CEO or president of the division of a public company;

Current or retired partners or managing directors of one of the major accounting firms, investment banks or private equity funds;

Demonstrated career achievement in noncorporate world, such as a former political officials, cabinet appointees, officers in armed forces, or CEOs of major NGOs;

Board members and leadership roles of a nonprofit organization or a private company with at least \$50 million in revenue;

Requisite approvals and ability to serve on a public board within two years. If a current partner of an accounting firm, within two years of mandatory retirement age.

BoardNext Membership

BoardNext Membership is by application. Participants must:

- · Meet the eligibility criteria;
- Complete the BoardNext application process;
- Pay a first-year membership fee of \$650 USD, then \$600 USD per year.

BoardNext is a customized membership for senior women executives striving for directorship on a for-profit corporate board or a private company with \$50 million in revenue or more.
